DESCRIPTION

LESCO Green is a permanent green pigment which will not injure turfgrass. It can be applied at any time during the year to beautify discolored turf. Grass can instantly become green when it is dormant. LESCO Green provides a natural green and healthy appearance to even the brownest grasses. It can also be added to golf course sand to create a green divot mix for top dressing.

DIRECTIONS FOR USE

SHAKE WELL BEFORE USE. Before applying LESCO Green, mow turfgrass area to desired height. One gallon of LESCO Green will cover 5,000 to 12,000 sq. ft. depending on type of spray equipment, condition and species of grass, mowing height, and desired color. Shorter mowing height and finer spray droplets will require the least volume of spray necessary for complete coverage.

For fall or winter application on dormant turf, dilute 1 gallon of LESCO Green with 10 to 20 gallons of water (6-12 oz./gal. of spray). This equals approximately 10 oz. LESCO Green per 1,000 sq. ft. Flat fan or cone nozzles producing fine droplet sizes will result in best turf canopy coverage. Two perpendicular applications are recommended to produce best color results.

For summer applications on discolored turf, dilute 1 gallon of LESCO Green with 15 to 25 gallons of water (5-8 oz./gal. of spray). This equals approximately 8 oz. LESCO Green per 1,000 sq. ft. Two perpendicular applications are recommended to produce best color results.

Do not apply LESCO Green when wind conditions favor drift. This is a permanent pigment and will adhere to any dry surface. Use only Teflon seals in centrifugal pumps to prevent leaks that may occur with ceramic seals. This type of flowable colorant may wear pump seals.

To color divot mix, spray LESCO Green onto sand as it is being mixed in a small cement-type mixer, wheel barrow, etc. Mix 6 oz. of LESCO Green with 100 lb. of sand to obtain a green colored divot mix.

STORAGE AND DISPOSAL

Keep from freezing. Do not re-use empty container. Safety goggles are recommended when handling the concentrate. If product is spilled, contain and absorb with inert material. Dispose of in accordance with local, state, and federal regulations.
