Burrow baiting with JAGUAR Rodenticide Place Pacs is prohibited.

Do not use in homes or human residences. Do not place near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food or feed handling equipment, or milk or meat handling equipment or surfaces that come into direct contact with food. Do not broadcast bait. HOUSE MICE AND MEADOW VOLES\*: Open pac and apply 1/4 to 1/2 oz, of bait per placement in infested areas. Space placements at 8 to 12 foot intervals. Larger placements, up to one unopened pac, may be needed at points of extremely high mouse or meadow vole\* activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Wearing gloves, collect and dispose of all dead, exposed animals and leftover bait. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
