MICRO-CAL EXTRA may be soil incorporated or applied to a wide variety of established turf grasses & newly seeded turf areas. If surface applying, apply only to dry turf and water in thoroughly after application.

• FOR EXISTING TURF: Coverage 15,150 to 21,700 sq ft. Apply 2.3 lbs to 3.3 lbs per 1000 sq. ft. To assure complete and even coverage apply at half rates in two directions. Apply to dry turf. Water in thoroughly.

MICRO-CAL EXTRA if used at 2.3 lbs per 1000 sq ft will provide 0.46 lbs of calcium and 0.03 lbs of sulfur per 1000 sq ft with each application. It is ideal for all turf types.
