- **FOR EXISTING TURF: Coverage 10 000sq ft.** Apply 5 lbs per 1000 sq. ft or 220 lbs per acre. To assure complete and even coverage apply at half rates in two directions. **Apply to dry turf. Water in thoroughly.**

SOLU-CAL K-CAL PLUS if used at 220 lbs per acre will provide 1.20 lbs of soluble potash, 0.50 lbs of calcium and 0.85 lbs of sulfur per 1000 sq ft with each application. It is ideal for all turf types.
